ORDINANCE NO: 736

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES FOR THE CITY OF MELVINDALE BY THE REPEAL OF SECTIONS 4-32(C)(1)&(2) AND RE-ADOPTION OF SECTION 4-32(C)(1) OF ARTICLE II “DOGS” IN CHAPTER 4 TO PROVIDE FOR THE ESTABLISHMENT OF LICENSE FEES BY COUNCIL RESOLUTION

THE CITY OF MELVINDALE ORDAINS:

ARTICLE I. Amendment: That Sections 4-32(C)(1)&(2), Chapter 4, Article II, are hereby repealed and re-adopted to hereafter read as follows:

©) Fees. Fees for dog licenses shall be as follows:

(1) Regular Fee. A per dog license fee as established by Council resolution.

(2) Deleted

ARTICLE II. Severability: Should any word, sentence, phrase or any portion of this Ordinance be held in a manner invalid by any Court of competent jurisdiction or by any agency having authority to do so for any reason whatsoever, including, but not limited to, a conflicting State law, such holding shall be construed and limited to such word, sentence, phrase or any portion of the Ordinance held to be invalid and shall not be construed as affecting the validity of any remaining words, sentences, phrases or portions of the Ordinance. Except as specifically amended herein, the sections of the ordinance which have not been amended herein shall remain in effect.

ARTICLE III. Saving Clause: Nothing in this Ordinance or in the Code hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance; nor shall the remaining Sections of this Ordinance be affected in any way, except as specifically amended herein.

ARTICLE IV. Conflicting Ordinances: All prior existing ordinances adopted by the City of Melvindale inconsistent or in conflict with the provisions of this Ordinance are, to the extent of such conflict or inconsistency, hereby expressly repealed.
